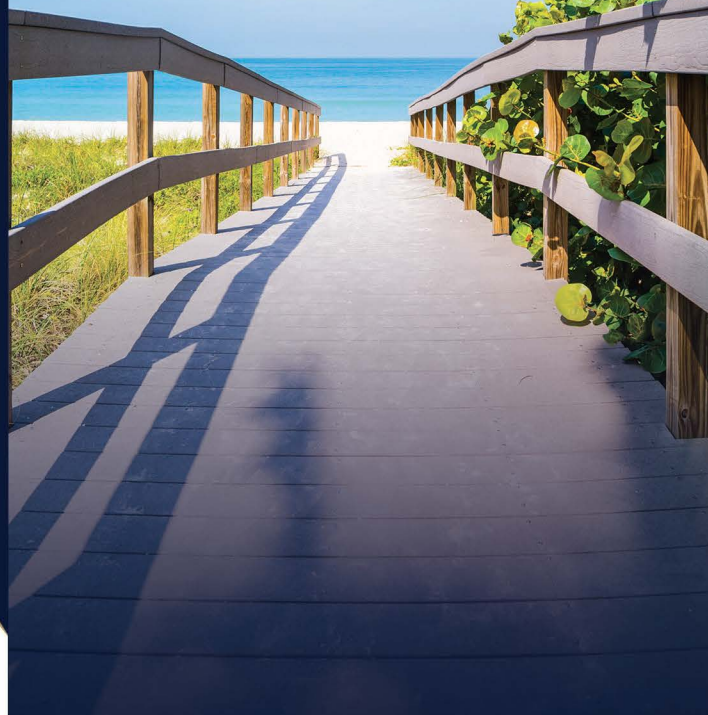

## THE CONCEPT BEHIND TREASURE COAST GIVING CIRCLE IS SIMPLE:

- A minimum of 50 men each contribute \$1,100 (\$1,000 grant/ \$100 administration).
- Contributions are pooled together to fund strategic impactful grants ranging from \$10,000-\$50,000 to non-profit organizations and academic institutions serving the Treasure Coast of Florida (Indian River, Martin, St. Lucie and Okeechobee Counties).
- Volunteers from the membership will review all applications, participate in site visits and select the grant finalists for consideration that have proposed programs/projects that demonstrate impact.
- All members will be provided with online access to the written applications of the grant finalists and will be able to vote for the grant recipient(s).
- All members and selected grant recipients will be invited to attend a reception where the awards will be announced and celebrated.

## TCGF MEMBERSHIP RESPONSIBILITIES:

- Become a member by making an annual tax-deductible contribution of \$1,100 (\$1,000 grant/\$100 administration)
